


2022 was Tiny Seed's fourth year of empowering project leaders to create positive change in their communities! We had a very successful year, with total program services funding increasing by 88% to \$650,178 and continued expansion of our portfolio of impactful programs working to further our mission.

In 2022, Tiny Seed sponsored 17 programs that align with our mission. Our collective is diverse and its programs address a range of important issues, including food security, habitat and species conservation, nature & arts, Indigenous people's food sovereignty, land rematriation, racial equity, regenerative agriculture, and energy efficiency.

Operating Model. Tiny Seed is currently run by three contract workers who provide operational, development, and financial services. In 2022, our contractors were paid from a combination of collective cost sharing agreements obtained from sponsored programs, as well as administrative costs budgeted into a USDA grant with our Northeast Grainshed Alliance program (awarded in 2020 and closed out in fall 2022). During 2023 one of Tiny Seed's primary strategic goals is to actively attract funding that allows creation of three permanent employee positions for our Directors of Operations, Development, and Finance.

Accounting, Legal, and Banking. Tiny Seed established a new relationship with G.T. Riley, a certified CPA firm based in Boston, MA, which reviews our financials and prepares our form 990. We also retained an attorney, Chris Logue, from Hurwit & Associates a nonprofit law firm based in Boston, MA. Chris has been a great asset to our organization providing feedback and reviews of our foundational documents and Fiscal Sponsor Agreement. We continue to value our excellent relationship with Community Bank NA, a large regional bank operating in the Northeast, and the banking home to all of our sponsored program accounts.



2022 REVENUE

Program Services: \$650,178 (+88%)

Sponsor Services: \$40,613 (+80%)


In 2022, Tiny Seed saw continued robust organic growth in Program Services revenue as we expanded our portfolio from 9 to 17 programs, and many existing programs increased fundraising activities. Total Program Services revenue increased 88% to \$650,178 and represents solid funding support from the following sources: private donations, foundations, government grants, corporate grants, and fundraising events.

To support Tiny Seed's administrative platform, Sponsor Services revenue increased 80% to \$40,613 as a result of collective cost sharing agreements with each project, as well as direct donations to support sponsor services overhead costs. We are an industry leader in terms of efficiency, with 93.8% of revenues available for program-related activities, with the remaining 6.2% for administration and operating expenses.

2022 ADMINISTRATION

Sponsor Services Expenses: \$47,777

Tiny Seed's administration expenses were very efficient at only 6.2% of consolidated revenue. Our largest administration expense (82.3%) consisted of contractor payments of \$39,310. Three contractors currently run day-to-day operations at Tiny Seed, and we anticipate attaining sufficient administrative funding during fiscal 2023 to transition to three fulltime employee roles for Directors of Operations, Development, and Finance.
